The fact is that the narrative in question is equally remarkable for its way of involving the visual imagination of its readers. «Writers attempt to break through the boundaries of their own medium», say V. Robillard and E. Jongeneel. The biblical writers did so, grafting the visible manifestation of God (in the Old Testament) and of Christ (in the New) upon their personal revelation as speaking characters.

#### **ABSTRACT**

Apocalypse as a literary genre is a debated issue. It can convey messages very different from each other, but it constantly presupposes a cultural conception of the world as structured on two levels and of human existence as needing knowledge about invisible, superior forces on which it depends. Really decisive knowledge can only be acquired by human beings through revelation coming from superior authorities. Such revelation can be transmitted through words, visions or (mostly) both. The present paper aims to synthesize some main features of vision(s) in early Jewish and Christian apocalypses, showing how those features are selected and combined with each other in function of the situation addressed by each apocalypse and of the envisaged answers to the involved problems. Who can receive a vision? Can a human being induce it? Does that vision take place inside the world of our daily experience or somewhere else? What means «seeing» in such circumstances? What does a seer see? Spiritual beings? God? A world hidden from our sensorial perception? How are visual and auditive revelations related to each other, and did their mutual proportion change in the process of time?

#### ABSTRACT

The comparison between the figure of Crete's Old Man (Dante, *Hell* XIV 94-120) and the statue seen in dream by Nebuchadnezzar king of Babylon in the biblical book of Daniel (chapter 2) obliges to compare also two different ways to interpret history: one is the vision of the classical world mastered by the idea of decadence, the other one is the Jewish-Christian perspective opened towards the messianic hope. Really both Prophet and Poet are influenced by classical culture. They, of course, expressed also a Jewish inheritance. For Dante the Golden Age is lost, though the Earthly Paradise is situated on the top of the purgatory so that it is reached by the souls. The most relevant novelty put into practice by Dante is that the great statue is characterized, in three of its four metals, by cracks from which tears flow to make the four rivers of the hell. The eternity of hell is nourished by human sins committed in the course of history. One way to define the hell is to say that there are human guilts undreamed forever.
