ABSTRACT

Giuseppe Accordini La teologia di Wolfhart Pannenberg nello specchio della storia (pagine 976-989)

ABSTRACT

History is the broader horizon in which also theology must be understood. The medieval lesson of Duns Scotus, which grounds theology and God himself in contingency, aims at overcoming metaphysics and rational ethics in order to reinterpret the same anthropology in the aesthetic and temporal horizon. The theology of the nineteenth and twentieth century partly enhances this perspective, and moves critically against the mathematical and geometric epistemology of science, without however affecting its anthropological absolutism. By playing the positive dialectic between infinite and finite against the negative dialectic, Pannenberg discovers the constitutive dimension of the infinite towards the finite and the original possibility of the latter to recognize it. The Trinitarian Absolute is therefore not confined to a mere manifestation of the absent, but is recognized as an actual occurrence in history.
